Section 7.6.21 of the Rhode Island General Laws

EXEMPTION FROM LIABILITY TO PARTICIPANTS IN SPONSORED ATHLETIC OR SPORTS EVENTS

"A non-business corporation as defined in 7.62, its officers, directors, sponsors, trustees, agents, servants, or employees shall not be liable for bodily injury to any person incurred while such person is practicing for or participating in any contest or exhibition of an athletic or sports nature sponsored by such non-business corporation provided such person has, or in the case of a minor, a parent or guardian has signed a written waiver of liability of such non-business corporation and acknowledgment of assumption of risk with respect to such practicing for or participating in any contest or exhibition of an athletic or sports nature sponsored by such non-business corporation."
